**AN ORDINANCE AMENDING CERTAIN PROVISIONS OF TITLE 11,
CHAPTER 1 SECTION 8 OF THE OAK LAWN VILLAGE CODE
ENTITLED "DELINQUENT PENALTY"**

WHEREAS, Section 6(a) of Article VII of the 1970 Constitution of the State of Illinois provides that any municipality which has a population of more than 25,000 is a home rule unit, and the Village of Oak Lawn, Cook County, Illinois, with a population in excess of 25,000 is, therefore, a home rule unit and, pursuant to the provisions of said Section 6(a) of Article VII, may exercise any power and perform any function pertaining to its government and affairs, including, but not limited to, the power to tax and to incur debt; and

WHEREAS, The Village President and Board of Trustees believe and hereby declare that it is in the best interests of the citizens of the Village of Lawn to amend Title 11, Chapter 1, Section 8 of the Oak Lawn Village Code; and

NOW, THEREFORE, BE IT ORDAINED BY THE PRESIDENT AND BOARD OF TRUSTEES OF THE VILLAGE OF OAK LAWN, COOK COUNTY ILLINOIS, PURSUANT TO THE VILLAGE'S HOME-RULE POWERS AS PROVIDED BY ARTICLE VII, SECTION 6 OF THE 1970 ILLINOIS CONSTITUTION, AS FOLLOWS:

SECTION ONE: The foregoing recitals shall be and are hereby incorporated as findings of fact as if said recitals were fully set forth herein.

SECTION TWO: That Title 11, Chapter 1 Section 8 of the Oak Lawn Village Code is hereby amended by deleting strikethrough language and incorporating additional language as follows:

If the owner of any motor vehicle who owned said vehicle on ~~July 31~~ August 1 of any calendar year fails to secure the necessary vehicle license on or before said date, and said owner was not excused from doing so under section 11-1-6 or 11-1-7 of this chapter, said owner shall be required to pay, in addition to the annual fee, the following sums:

SECTION THREE: The amendment as set forth hereinabove shall be effective as of July 31, 2016.

SECTION FOUR: Any policy resolution or ordinance of the Village that conflicts with the provisions of this ordinance shall be and is hereby repealed to the extent of such conflict.

SECTION FIVE: This ordinance shall be in full force and effect from and after its passage and approval in the manner provided by law.


